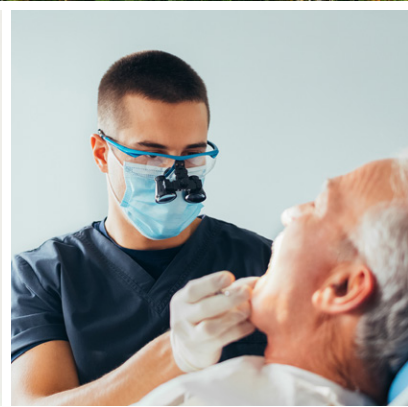

## OUR HISTORY

WPHP was founded in 1986 by a group of concerned members of the Washington State Medical Association who wanted their colleagues to receive treatment, rather than discipline, when illness threatened safe practice. Today, WPHP is an independent, physician-led, nonprofit organization providing critical support to Washington's health professional workforce. With 40 years of developed expertise, service commitment, and outstanding outcomes, WPHP has earned the trust and support of the medical community in Washington and the program participants we serve.

## CONFIDENTIAL HELP

One of the reasons the physician health program model was developed was to provide confidentiality for health professionals with stigmatized health conditions as they are more likely to seek assistance when their information is kept private.

Maintaining participant confidentiality is an essential element of our program. Existing state and federal laws allow WPHP to protect the identity of referents and participants when they follow WPHP recommendations and do not pose a risk to themselves or their patients.

Once a health professional is treated or has entered a health support agreement, WPHP can advocate on their behalf in employment, insurance, regulatory, and legal matters or in other settings where the health condition may have professional consequences.

WPHP's endorsement of safety to practice provides reassurance that a professional's health condition is being appropriately managed, paving the way for continuation of practice or return to work following a medical leave.

## TRUSTED ADVOCACY

A key component of WPHP's mission is advocacy. WPHP participants report that our advocacy is essential to their success and well-being. Core advocacy efforts include providing verification of health status, program participation, and safety to practice. In all circumstances, WPHP delivers trusted, credible, and timely advocacy when participants need it most. We also continue to make tremendous strides locally and nationally in advocating for license and credentialing question reforms and addressing other systemic barriers to mental health and well-being.

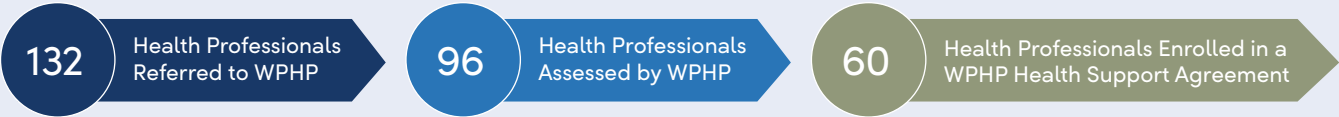

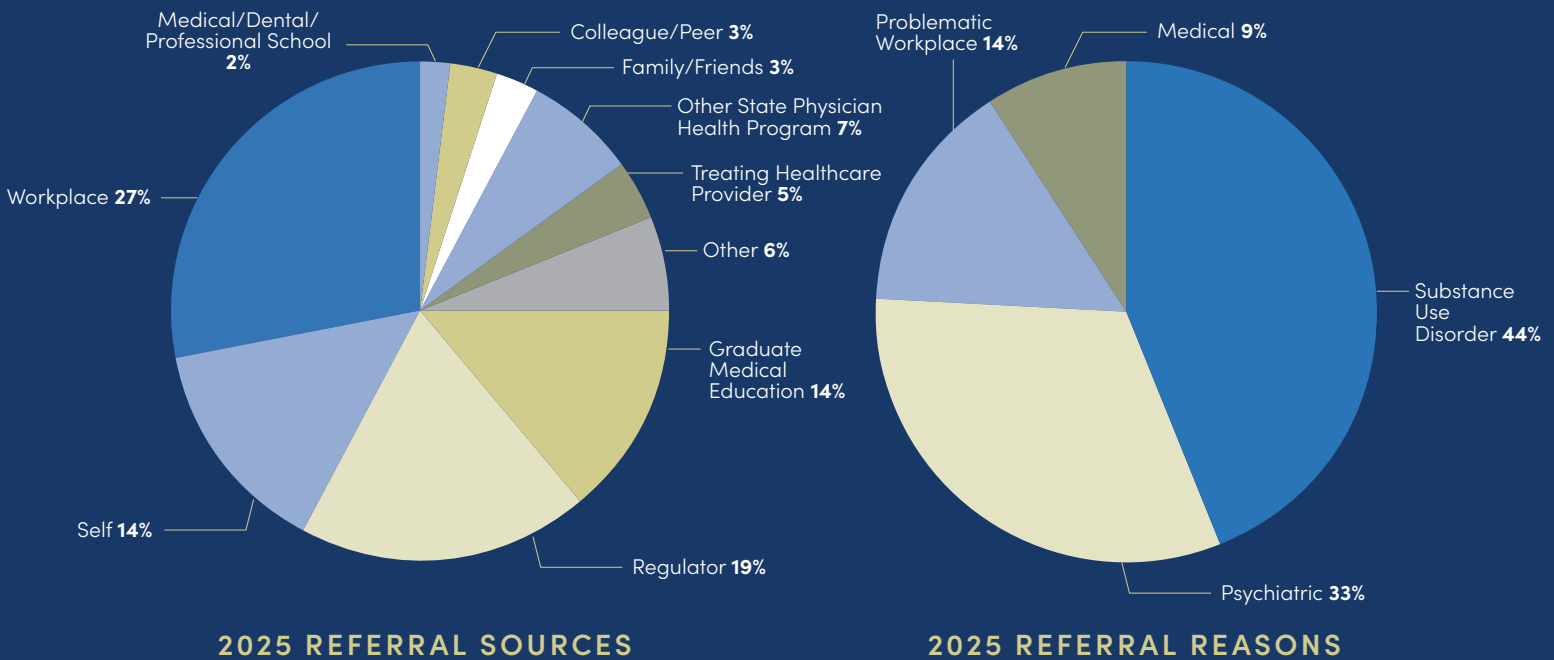
## Support is Offered, Concerns are Put to Rest

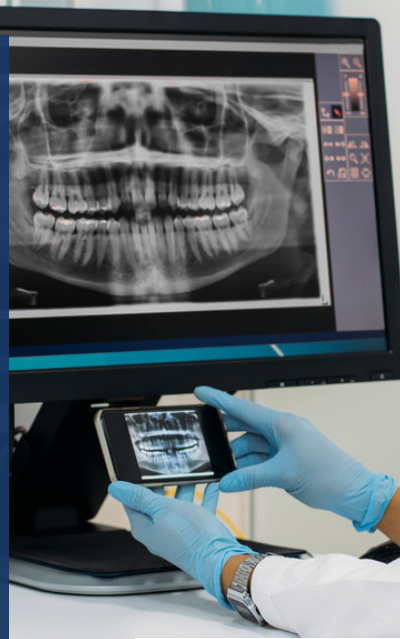

## 2025 WPHP HIGHLIGHTS & MILESTONES

### ANNUAL REUNION CELEBRATES 30-YEAR ANNIVERSARY

WPHP marked its 30th Annual Reunion with a dynamic and thoughtfully curated program that reflected three decades of commitment to supporting health, connection, and community. The reunion featured engaging presentations, interactive workshops, and powerful personal stories, all grounded in meaningful fellowship. The program included nationally recognized speakers addressing timely and relevant topics. Emily Brunner, MD, DFASAM, presented *Digital Behavioral Addictions: Current Perspectives*. Stefanie Simmons, MD, FACEP, Chief Medical Officer of the Dr. Lorna Breen Heroes' Foundation, delivered *Wellbeing First for Healthcare*. WPHP and the Dr. Lorna Breen Heroes' Foundation are united in advocating for a system where seeking mental health support is not a risk, but a right. Jeffrey Sung, MD, explored *Stories About Suicide: Science, Advocacy, and Suicide Risk*. And Carolyn McCarthy of Mindfulness Northwest led an interactive workshop on *Mindfulness & Self-Compassion*. Attendees also had the opportunity to earn continuing education credits.

### DRIVING OPERATIONAL EXCELLENCE, AWARENESS, AND ADVOCACY

WPHP advanced a series of initiatives to enhance operational efficiency and program services in 2025. Key efforts included redesigning program components, assessing records management systems, and piloting an innovative toxicology solution that delivers high-quality testing while balancing credibility, convenience, and cost. WPHP also continued to execute its strategic communications plan aimed at increasing awareness of WPHP and advancing advocacy on healthcare issues.

### IMPACT VIDEO LAUNCHES

WPHP produced its first-ever video, showcasing our mission, measurable outcomes, and the transformative impact of our work. The video also underscores WPHP's vital role in supporting health professionals.

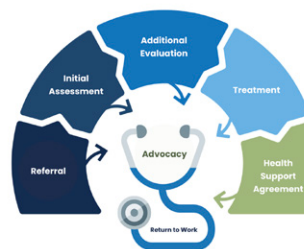


### CREDENTIALING REFORM EFFORTS ADVANCE

WPHP collaborated on a groundbreaking development in healthcare credentialing, led by Dr. Brian Johnston of UW Medicine. This landmark reform set a new standard for credentialing processes, placing a strong emphasis on the well-being and mental health of health professionals. WPHP played a critical role in providing consultation and technical assistance throughout this initiative.

WPHP also led the Washington Credentialing Standardization Group to bring the Washington Practitioner Application (WPA) into alignment with credentialing best practice. New questions will ask only about current impairment and not ask about past diagnosis or treatment. The WPA is the most commonly used credentialing application for health care systems and plans in Washington.

WPHP created a step-by-step guide outlining what to expect if referred to or when referring a colleague to WPHP. The diagram communicates each phase of WPHP's process and illustrates potential pathways for health professionals.

### Contributions To The Federation Of State Physician Health Programs Annual Education Conference

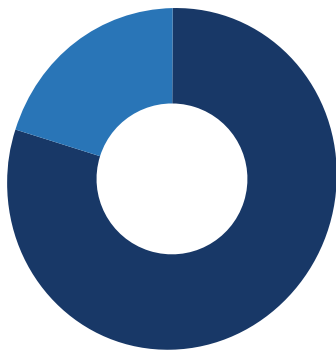

# 2025 FINANCIAL SNAPSHOT

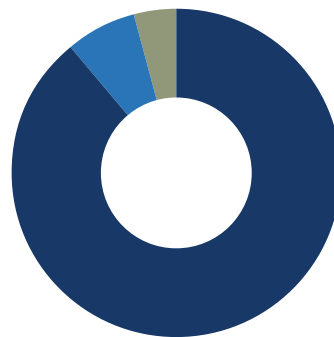

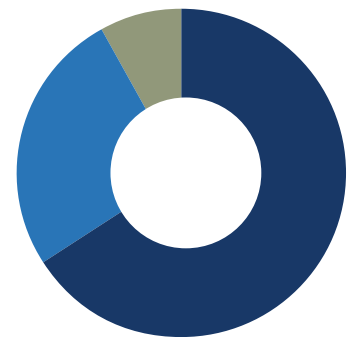

## MISSION

## WPHP IS EXPERIENCED & HIGHLY EFFECTIVE

We have been serving health professionals and the medical community in Washington for 40 years. There is no model of care that approaches the success that WPHP participants enjoy.<sup>1</sup>

## WPHP IS VOLUNTARY

Participants may self-refer to WPHP or be offered an opportunity to work with WPHP to address health conditions that may negatively impact practice performance. 87% of participants are enrolled in WPHP without regulator involvement.

## WPHP IS CONFIDENTIAL

- WPHP records have special confidentiality protections per RCW 18.130.175 which make them exceedingly difficult to obtain by subpoena or court order.
- As long as there are no concerns for patient safety, participant information is kept strictly confidential to WPHP and only released with appropriate consent.
- **Fewer than 5% of participants forfeit confidentiality due to WPHP's mandated reporting requirement.**



## WPHP IS NOT THE MEDICAL/LICENSING BOARD

# WPHP IS COMPASSIONATE, FAIR, AND HIGHLY ETHICAL

- 90% of program graduates report being treated with courtesy and respect by WPHP staff.
- Full informed consent occurs at the initial interview including limits of confidentiality, risk, benefits, and alternatives to program participation.
- WPHP utilizes a meaningful reconsideration process to resolve disagreements.
- WPHP is a nonprofit 501(c)(3) organization that is funded 89% by an annual license surcharge with participant fees accounting for 7% of total revenue. The cost of serving each participant exceeds the fees collected and is below our operating expenses. WPHP does not realize any net financial gain from participant referrals or enrollment.
- WPHP has a strong conflict-of-interest/anti-kickback policy and receives no funds from evaluation or treatment centers or any entity with a business interest in WPHP.
- WPHP provides need-based scholarships, payment options, and fee deferral agreements. Grants totaling \$207,450 were provided to 73 participants in need during 2025. Nobody is turned away due to inability to pay.

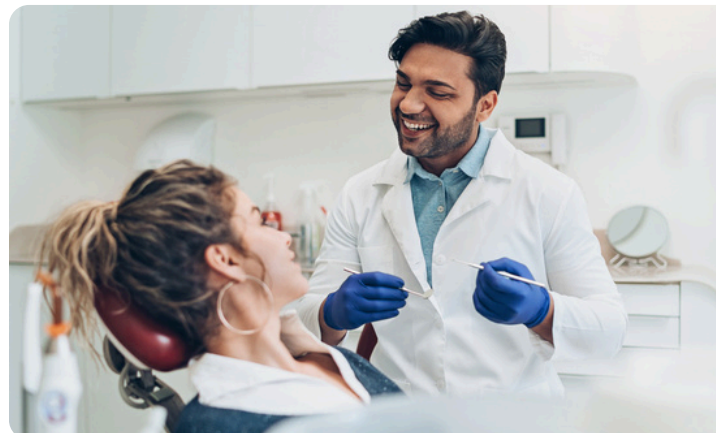


## WPHP IS A NATIONAL LEADER AMONG PHYSICIAN HEALTH PROGRAMS

## WPHP IS ACCOUNTABLE

- Governed by a Board of Directors representing diverse stakeholders. WPHP Board of Directors and Bylaws must be approved by the Executive Committee of the Washington State Medical Association (WSMA) Board of Trustees.
- Quarterly reports to the WSMA Board of Trustees and a comprehensive program report annually to the WSMA House of Delegates.
- Detailed quarterly statistical reporting to Department of Health (DOH) and comprehensive annual program reporting.
- Annual and exit surveys of program participants and stakeholders.

## OVERVIEW

For 40 years, Washington Physicians Health Program (WPHP) has been Washington's trusted resource for restoring the health of medical professionals. Our confidential support and exceptional outcomes provide reassurance of safe practice and promote workforce sustainability. WPHP is an independent, physician-led, nonprofit organization.

## PROGRAM HIGHLIGHTS

WPHP offers early intervention, assessment, treatment referral, and post-treatment health support for those in the medical workforce with conditions that may negatively impact practice performance. In some cases, brief assessment and referral to services are all that is needed to support health and put concerns at rest. In other cases, more help is needed and WPHP is ready to assist. Referrals to WPHP protect the well-being of health professionals and the patients they serve.

## WPHP WORKS

- WPHP is highly effective with 88% of participants report needing and benefiting from WPHP advocacy.
- 87% of participants are working in their field at program completion.
- 85% of participants with substance use disorder remain abstinent at 5 years.
- 84% of colleagues report that WPHP is a valuable resource to the medical community.
- 81% of colleagues would refer another colleague to WPHP.
- 48% of program participants describe their participation in WPHP as lifesaving.

## WPHP TIMELINE

**1973**

- ▶ The Journal of the American Medical Association (JAMA) publishes the seminal article "The Sick Physician."

**1974**

- ▶ The Washington State Medical Association Committee (WSMA) creates the Committee on Personal Problems of Physicians.

**1986**

- ▶ WSMA establishes the Washington Monitored Treatment Program Committee to help impaired physicians and protect the public.
- ▶ WSMA lobbies the Washington State Legislature for surcharge funding support and appoints an independent board for the Washington Monitored Treatment Program Committee.

**1992**

- ▶ The Washington Monitored Treatment Program Committee becomes the Washington Physicians Health Program (WPHP).
  - Physician-led, independent, nonprofit 501(c)(3) organization
  - Funded by license surcharges through Washington's Department of Health (DOH) contract
  - Governed by a Board of Directors approved by WSMA

**1997**

- ▶ WPHP expands its scope to include mental illness in addition to substance use disorder.

**2003**

- ▶ WPHP adds staff and services to accommodate a surge in participants and establishes a national PHP leadership prominence.

**2008**

- ▶ WPHP continues to expand its scope to include psychiatric impairments in addition to substance use disorder and mental illness.

## WPHP AFFILIATIONS

WPHP is an affiliated training site for the **University of Washington Department of Psychiatry and Behavioral Sciences Residency Training Program**. Chris Bundy, MD, MPH, WPHP's Executive Medical Director, is a Clinical Professor in the department and is a supervisor for this training site. He is also active in the supervision of psychiatry residents and regularly lectures to medical students, trainees, and faculty on topics related to physician health and impairment.

WPHP is a member of the **Federation of State Physician Health Programs (FSPHP)**, a national membership organization that provides a forum for guidance, education, and research collaboration among state physician health programs. The FSPHP develops evidence-based guidelines for healthcare professional monitoring programs. Dr. Bundy is the Chief Medical Officer and a Past President of the organization. Laura Moss, MD, WPHP's Associate Medical Director, has served as Western Region Director on the FSPHP Board since 2022.
